

Visa, Mastercard, and Discover chargebacks and other events that trigger exceptional fees are an expected part of payment processing. SwyftSwipe Updater is a service that may abate these fees.

For a monthly subscription of \$16 (less than the cost of a single chargeback) SwyftSwipe Updater alerts you of credit card info that is invalid or expired. If available, obsolete data will be automatically replaced. (Each discrepancy results in an additional 60¢ fee.)
